#### JOINT STATUS REPORT APRIL 14, 2023

COME NOW Plaintiffs, by and through Class Counsel, and Defendants, by and through their undersigned counsel, and respectfully state as follows for their Joint Status Report:

- 1. <u>Class Member Checks Cashed/Outstanding</u>: Of the 120,086 checks (reissues and second distributions) that have been mailed, 68,868 have now cleared totaling \$854,755.32 and 51,218 checks totaling \$329,856.62 are currently outstanding.
- 2. <u>Class Member Checks Returned as Undeliverable</u>: The Settlement Administrator has now received 2,829 checks returned as undeliverable. 180 of these returns had forwarding addresses provided by the post office, and those were remailed immediately. Of the 2,649 checks that were returned with no forwarding addresses, 990 were for \$5.00 or more and were sent for skip tracing and remailing if a new address is located. Of the 990 sent for skip tracing, 341 came back with a new address, and the Settlement Administrator has reissued and mailed those checks.

WHEREFORE, Plaintiffs and Defendants respectfully request that the Court accept this Joint Status Report.
